1. Those who inherit by fardh alone:

2. Those who inherit by ta'sīb alone:

1. If they are the only inheritors, they inherit all wealth
2. If they inherit alongside someone who receives a fardh amount, they receive what remains after the fardh is taken
3. If those who receive by fardh take the full amount, they receive nothing
